"Passenger service between Providence and Newport was instituted about 1764 by regular sailings of a packet from Hacker's Wharf, located near the foot of the present Planet Street. Joshua Hacker, its proprietor, formerly of Salem, built a house on the E side of the Towne Street (now South Main)opposite his wharf, which he later converted into a place of entertainment known as Hacker's Hall. Balls and parties were held there by the elite of the town, invitations to which were printed on playing cards. Among the distinguished guests entertained at the hall were Washington, varnum, Gates, and Rochambeau." from CIVIU & ARCHITECTURAL DEVELOPMENTOF PROVIDENCE by John Hutchins Cady..p 37

..."before making his adieux in 1782 Rochambeau "gave a very splendid ball at Hacker's Hall to the ladies and gentlemen of the town".. Ibid p 54

Joseph Peck, son of Winchester, settled in Providence R I where he became engaged in trade, and where he lived and died. He married Sarah Hacker daughter of Joshua Hacker of Newport R I. During the great fire of 1801 his store, and much property was burned. He afterwards erected upon the same ground the BRICK building now standing on the E side of South Main Street between Plant and Power Street. from "Descendants of Joseph Peck" p 148 RIHS
