- 1819 Thomas Addison sells for \$300 to Thomas Howard, cabinet maker, a certain lot of land containing all the land that Gideon Hull purchased of John Burroughs in 1793 (DB23.256) and of John and Sarah Jenkins in 1794 (22.637) 638,539)...the part hereby conveyed being same I bought of Joseph Hull in 1817 (DB40.182) and of Elizabeth Hull in 1817 (DB41.83)..DB 43.153
- 1825 Thomas Howard sells for \$1200 to Solomon H Kenyon, physician, this property "it being the same Estate I purchased of Thomas Addison et al in 1819...DB 50.51...Bounded: W by S Main Street 52½'; N by heirs of Nicholas Power 60'; E by heirs of John Tillinghast 52½'; S by Harding's Alley 60' ...DB 50.51
- 1825 Solomon H Kenyon sells the above property to Amos Collins...50.179
- 1826 Amos Collins sells to Jonathan Pike...being the same Estate I purchased of Solomon Kenyon in 1825...DB52.58
- 1826 Jonathan Pike, housewright, sells the above property to William C Barker...DB 52.32
- 1826 William C Barker, merchant tailor, sells for \$600 to Enoch Steer a certain lot of land bounded: W by South Main Street 31½'; N by heirs of Nicholas Power 50'; E by heirs of John Tillinghast 16'; S by grantor 48'..it is part of the same Estate conveyed to me by Jonathan Pike in 1826 (DB 52.32) and is meant to convey all the vacant land lying N of said grantor's house belonging to him...DB 52.48
- 1830 John Calder lived here at #116...Prov Dir
- 1830 Enoch Steere and Mrs Tillinghast, widow, lived here...Prov Dir
- 1870 WILL:...Rhoda Steere..."To my beloved husband Enoch, all my Real Estate during his natural life. At his demise I give to my daughters Mary Ann Steere and Almira Greene Taylor, each ¼ part of the income from my Real Estate and to William H Peck Steere during his natural life ½ of the income from my Real Estate. At his demise all my Real Estate equally divided between my two daughters...Wills 23.90
- 1903 Property was taxed to Almira G Taylor
