Built in 1851 for Henry B. Drowne

- Deed Book 13.217 Stephen Jackson purchased the Benefit St.
 lot from John Mauney. Jackson was a Providence schoolmaster.
 - Samuel and Elizabeth Jackson were brother and sister living
- 1759 Inhabitants of Providence, Plate III by Henry Chace shows this lot contained a dwelling house which was occupied by Samuel Jackson.
- April 21. Elizabeth Jackson, sister of Samuel, was married to William Lanksford. (Vitals M.B. 1.172)
- The Chace map (Plate III) shows this lot contained a house and barn. It was still owner-occupied by Samuel Jackson.
- Samuel Jackson died leaving his sister Elizabeth Lanksford (widow) his entire estate. Probate Docket #A4073 W.B. 10:636.

Susan Lanksford Cole, who was the daughter of Elizabeth Lanksford, inherited the property from her mother. (D.B. 109.176). Susan became the wife of Cyrus Cole on Aug. 9, 1806 (M.B. 5.298). Cyrus' first marriage was to Maria Jackson on Feb. 27, 1800 (BK 5.277).

Cyrus Cole was administrator of 73 acres of the Richard Brown Estate Farm located in Prov. Neck (DB 36.54). After Cole became administrator of his wife's inheritance (Jackson property and the Neck Farm), many of the legal documents pertaining to land transfer and rental were contained in one instrument.

- 1817 Cyrus Cole left his estate to his wife Susan. Probate Docket A5809; WB 12:258.
- April 10. Deed Book 105.467 Susan Cole, widow, placed Samuel Jackson Cole, attorney, trustee in charge of her estate to rent, lease, sell and pay just debts.
- March 9. Deed Book 109.174 Susan Cole of Upper Alton, Illinois, Madison County, conveyed to William S. Humphreys for \$3,000 the land with a dwelling house and all other improvements situated on the easterly side of Benefit Street described as bounding west on Benefit St. 40' holding that width extending back 130'; bounded north by land of Ann Allen,

south and east by land of Edward H. Harris. Susan Cole had been renting a dwelling house to Ezra Hubbard, but it is not exactly clear if it is the Benefit St. house.

Directories for 1841-42 show William S. Humphreys was an accountant at 133 North Main Street. In 1850 he was living on Angell Street, corner of Brown, and in 1853-54 he lived on Benevolent.

- March 18. Deed Book 120.140 For the purpose of straightening the lines of adjoining lands Humphreys and his neighbors conveyed certain strips of land to each other. For further details see Deed Book 120.140 and Plat Book 3 p.36. No dwelling house is mentioned.
- March 7. Deed Book 122.225 William S. Humphreys and his wife Amy conveyed the property to Henry B. Drowne. Henry Drowne was not listed in the Providence Directory prior to this date.

Policy Record #20345, page 87, shows Drowne insured his dwelling on Benefit Street described as being a wood building, basement of brick, 31' X 54', 3 stories in front on Benefit Street, 2 in the rear. Architectural research by the Historic Preservation Commission indiactes that the house was built at this time.

- Directories show the following as occupants of 81 Benefit, (now 125 Benefit)

- August 1. Tax Ledger 1.261 Series A shows this lot contained 4864 Sq. Ft. and valued at \$4864. The building was valued at \$4500.

- March 7. George R. Drowne filed an "Intention To Build" on his lot located on the east side of Benefit Street. This became #119 Benefit. Henry B. retained the next lot to the south untill 1888 (Death Vitals: Oct. 18, 1888)
- August 7. Deed Book 175.311 Henry B. Drowne conveyed to Stafford Drowne of Brooklyn N.Y. said lot with dwelling house now known as 121, 123, 125 and 127 Benefit. Further described as being on the east side of Benefit at the southwest corner opposite Cady St. and running north on Benefit 42'; then east on adjoining land of G.A. Seagrave 130'; then north on adjoining land of Samuel A. Trippe 37'; thence west on adjoining Trippe land 130' to the point and place of begining.

125 Benefit Street (page 3)

This is the same parcel conveyed to Drowne from Hymphreys except that there was an exchange with E.H. Harris of 2' having been added to the width and approximately 3' taken from the rear. This conveyance was for \$9750.

- June 1. Tax Ledger 9.368 Series E The property was transfered to Henry J. Steere. Directories list Steere as Treasurer of Wanskuk Co. with an office at 56 Westminster St. Steere lived at 101 Benefit and died on October 28, 1889 apparently before moving into 125 Behefit.
- June 1. Frank E. Seagrave, who had lived at 119 Benefit St. for a number of years, purchased #123 127. He was treasurer of Central Falls Woolen Mills with an office at 65 Westminster St. It is unclear to whom he rented #123-127 until 1895 when we have a dressmanker listed, Mrs. J.A. Brady, at #125. At #127 we have listed a M. A. Gardner boarding house with the following occupants:

Frederick Hayes; lawyer
Miss Sarah S. Mumford
Emery C. Sampson; collector
Frank S. Smith; clerk
John S. Townsend; agent.

- 1895 See map attached
- November 1 through 1912 the property was in the hands of the Seagrave Trust administered by Industrial Trust Co. (Docket #13415) During this time it remained a boarding house and dressmaker shop.
- 1913 Tax Cards show it was purchased by Mary A. Needham, wife of Thomas H. Needham. Thomas Needham was a toolmaker.
- June 14. Probate Docket #19707. Mrs. Needham, widow of Thomas, retained the property in her name alone.
- December. Deed Book 733.287 The property was purchased by Mary M. Fraser. She retained the parcel until 1963. From 1929 until about 1940 the first floor was occupied by Ideal Rus Works Weaving Co. #127 was occupied by Mrs. Mary A. Needham; #129 by Frank S. Broadbent.
- 1942 Mrs. Bessie Gurnick, grocer, occupied #125. At #127 was the Frederick J. Reavey Lodging House.

December. Assessors W.B. 12.585 Joseph M. Cota became owner of the property.

#125 was occupied by Olivo Art Gallery #127 " " Rose Brelsford.

- November 4. Deed Book 1128.375 The property was placed in the name of P.O.M. Realty, Inc. The occupants remained unchanged.
- April I. Deed Book 1152.44 Olivo Gallery, Inc., occupant since 1963, purchased the property.
- July 24. Deed Book 1182.236 P.D.N. Corporation gained title. Olivo Art Gallery remained plus Josephine's Antiques. Various documents also show 11 apts at this time.
- January 18. Deed Book 1217.883 C.J.S. Enterprises purchased the property.

#125 was occupied by Alice King's Benefit St. Gallery and Antiques. #127 - apts.

1983 to present - October 6. Deed Book 1249.232 The property was purchased by Henry A. Schult.

#125 was occupied by Nancy Taylor Interiors and Benefit St. Antiques.
