1839 STANTON BEEBE SELLS FOR \$3300 TO CHARLES SHAW TWO LOTS OF LAND WITH BUILDINGS THEREON..."THE FIRST BEING LOT #5 IN THE DIVISION OF THE ESTATE OF STEPHEN HARRIS WHICH FELL TO ABBY HARRIS AND CONVEYED BY HER TO GRANTOR IN 1828...75/152

1848 CHARLES SHAW SELLS FOR \$2375 TO HIRAM COOKE A CERTAIN LOT OF LAND BOUNDED N BY CADY LANE 30'; W BY A 10' GANGWAY 50'; S BY GRANTOR 30'; E BY GRANTOR 50', WITH DWELLING HOUSE, ALSO ON THE LAND HEREBY CONVEYED THE NECESSARY THEREON AND WELL PRIVILEGES...109/120

1850 HIRAM COOKE SELLS FOR \$2600 TO NATHANIEL P BARTLETT "ONE LOT OF LAND WITH DWELLING HOUSE SAME BOUNDARIES AS ABOVE PROPERTY...122/57
