- Robert Taft sells for \$17000 the above property to Jonah Steere... "being the same conveyed to grantor by S Hutchins and E A Greene mortgagors of Asa Newell in 1854 and also by deed from Aseneth A Newell..DB 174.204
- 1890 Property was taxed to Henry J Steere Estate.
- Alfred Metcalf u/w Henry J Steere sells for \$3700 THE WEST PART of the above property being that lot of land and buildings on the N side of Cady Street bounded: N by T Merriweather 38; E by Robert Steere 69; S by Cady Street 42; W by Abby Martin and T Merriweather 69...DB 369.387
  - 1892 Nohm J Scattergood lived here and until 1895 (Providence Directory)
- 1905 Property was taxed to Annie Doyle
- 1919 Mary Coffey owned this property
